- The European Consortium for Accreditation in Higher Education (ECA) is pleased to announce its website: www.eaconsortium.net If you have any suggestions for improvement or questions please contact Mark Fredericks, ECA Coordinator at m.frederiks@nvaio.net
- The South African Council on Higher Education has withdrawn accreditation from ten of the country's 28 MBA programmes. Most of the programmes are in small private institutions but large public institutions such as the University of Natal have also lost their accreditation. - The Council for Higher Education and Accreditation (CHEA) has expressed "concern and alarm" over a major bill on higher education (HR 4283) in accreditation. While the provisions of the bill would enact provisions that would strengthen accountability in ways advocated by CHEA it would also authorise major governmental inclusion in matters of academic quality.

The provisions of the bill include the following requirements:

Accreditors would have to produce a public summary of their actions and findings when accreditation status is granted or renewed.

Institutions would need to state the learning objectives for their programmes.

Accreditors would be required to demonstrate to federal officials that the quality of distance learning in the institutions they accredit is comparable to face to face provision.

- The Malaysian announced in April that in future that applications to offer franchised programmes from foreign universities in Malaysia will normally only be approved if the foreign university is

sufficiently highly ranked in national league tables. For example, in the case of the United Kingdom, the university must be ranked in the top 60 by the Times Good University Guide, Financial Times or Daily Telegraph. In the United States, the Malaysian government will rely on publications such as Peterson's US Colleges & University Handbook.
