The AEC has successfully lobbied the European Parliament to ensure that the cultural dimension in the proposal for [Key Competences for Lifelong Learning](#) is strengthened. After circulating a document with comments to various Members of the European Parliament (MEPs), several

The Commission is urging Member States to free up the EU's substantial reservoir of knowledge, talent and energy with immediate, in-depth and coordinated change: from the way in which higher education systems are regulated and managed, to the ways in which institutions are governed.
