



### Greetings to Members of INQAAHE

The Board has been very active during the last few months, and many projects are in progress.

### Professional Qualifications in QA

Jean Morse is leading a Group in developing formal qualifications for those who work in the quality assurance field. About 16 professionals from around the world are beginning to write course material, with a target date of the end of 2008. These materials will be in the public domain.

At the next stage, INQAAHE will work with two universities (the University of Melbourne and New York University) to build the INQAAHE course materials into on-line courses. The first two modules of a four-module Graduate Certificate should be ready for enrolment by the middle of 2009.

At a late stage, more modules may be added to form a Master course. This work is being supported by a World Bank grant.

### Good Practices in QA

A group led by Janice Ross is analysing good practices in QA (GPQA) submitted by member agencies. The first Good Practices were received by 1 September and should be on the web site within a couple of months. Further Good Practices are invited and may be submitted at any time. ### Query Service

The rapid answer Query Service now available on the INQAAHE website provides advice from a range of senior people in member agencies. ### Clearinghouse

I am leading a group that is creating a Clearinghouse (QAHEC) of policies, procedures and practices of quality agencies. This is akin to an ERIC database for QA. All of us now use the power of general search engines, such as Google and Yahoo. What QAHEC will offer in comparison with a general search is a distillation, definition and commentary on the concepts and practices indexed. This will be available by the end of 2008. The target is to catalogue 20 agencies by that time, and 50 by the time of the 2009 conference. This work is being supported by a World Bank grant.

### Reviewers and Consultants

The Asia-Pacific Quality Network has World Bank support to create a database of reviewers and consultants for that region. INQAAHE is contributing to the project, led by Antony Stella, in order to extend its coverage world-wide.

### Board Directors

Since the last bulletin, Dr Lis Lange and Mr Seamus Puirseil have left the Board and Dr Carol Bobby has joined. We still have two vacant slots, so anyone who would like to volunteer for appointment to the Board should contact me. We need people who are lively, active and thoughtful, and who are willing to work on one or two of the Network's project groups.

### Professional Accreditors

Carol Bobby has taken on the task of developing INQAAHE's relations with professional accreditors. Two other people from that constituency have expressed an interest in working with her. The Board is considering some initial proposals to strengthen our work in this area.

### Memorandum of Co-operation

A MoC has been signed between INQAAHE and ANQAAHE, specifically referring to the Consultants and Reviewers Database.

### Liaison Person

Norman Sharp has kindly agreed to replace Peter Cheung as networks liaison person.

### Networks Meeting

There will be a meeting of the networks associated with the CHEA meeting in January 2009 (as this year).

### Other Matters

Other matters, such as the progress of the 2009 INQAAHE Conference and the handover of the Secretariat from HETAC to NVAO are described elsewhere in this Bulletin.

NVAO is active in both countries in the field of Quality Assurance in Higher Education, and also takes part in a considerable number of international activities. In 2006, NVAO hosted the INQAAHE Workshop in The Hague. NVAO also participates in the Board of the European network ENQA, and provides the secretariat and vice-chair for the European Consortium for Accreditation (ECA). We are proud to be able to contribute to the worldwide INQAAHE network activities.

The team that within NVAO in particular will work for INQAAHE consists of three persons: Leendert Klaassen, member of the Executive Board of NVAO, is appointed Secretary of the Board of INQAAHE; Mark Frederiks, policy advisor international affairs, will act as Administrator of INQAAHE; Esther van den Heuvel is charged with various support activities, particularly in maintaining the website and developing contacts with INQAAHE members.

## Project collaboration

INQAAHE wrote to all the networks about collaboration on GIQAC and other projects. Combining the responses from three networks with the information shared at the meeting in May, there is scope for collaboration on projects as follows:

- Consultants database – APQN/INQAAHE/ANQAHE
- Training materials – APQN/RIACES/INQAAHE/ANQAHE
- Clearinghouse – RIACES/INQAAHE

Also, CANQATE indicated interest in collaboration with RIACES on Internships, External Review Visits, Study Visits and Research Studies.

## GIQAC Projects

In May, INQAAHE decided that it would report on the INQAAHE website the funds received by INQAAHE from GIQAC, and ask the other four recipient networks to provide information on their projects that have been supported by GIQAC. This information was not placed on the INQAAHE website, GIQAC created its own website with this information and we are linking to it.



## Results of Japanese accreditation

In 2007, the Japan University Accreditation Association (JUAA) accepted the applications for University Accreditation (the 4th conducted by JUAA) from 54 universities, and their applications were carefully reviewed by approximately 650 people serving in 179 subcommittees and panels under the University Accreditation Committee. Of the 54 universities that applied for accreditation, 50 universities were accredited as passing the University Standards for accrediting universities set by JUAA.

## Quality Assurance Principles

From 19-22 February a workshop on higher education quality assurance in the Asia-Pacific, was held in association with the Asia Pacific Quality Network annual meeting which took place from 19-22 February. The workshop provided the opportunity for a regional discussion on the findings of a scoping study, which DEEWR had commissioned APQN to be responsible for, of quality assurance in the Asia-Pacific region and the possibility of developing a set of joint quality assurance principles for the countries in the region. ## First accreditation CCA

On August 14th the Central American Council for Higher Education Accreditation (CCA) granted its first accreditation to the National System of Higher Education (SINAES) of Costa Rica. The accreditation model of the CCA is based on the standards and criteria of internationally recognized good practices. CCA's mission is to promote the improvement of the quality of the higher education institutions in Central America. This will be done together with national and regional agencies that are acknowledged by the CCA. Dr. Gabriel Macaya Trejos is the president of the CCA and Licda. ## APQN-GIQAC Projects

Earlier this year the Asia Pacific Quality Network (APQN) secured a grant through UNESCO in the form of the Global Initiative in Quality Assurance Capacity (GIQAC). The approved proposal covers four projects. One of them is **the Internship and Cross-regional Staff Exchange Programme.**

On 11 August 2008, the Philippine Accrediting Association of Schools, Colleges and Universities (PAASCU) launched the Internship and Cross-regional Staff Exchange Program. Staff members of accrediting agencies from Bangladesh, Cambodia, Indonesia, Mongolia and Vietnam have been invited to participate in the 2-week internship program which will run until February 2009.

Pen Sithol, Director of the Department of Standards in the Accreditation Committee of Cambodia and Lay Sopagna, a staff member of the same agency, were the first interns to participate in the program, which lasted until 23 August 2008. The program consisted of hands-on activities in the PAASCU Secretariat, meetings with the host agency and visits to institutions in various stages of the accreditation process. The interns also joined an actual accreditation visit to the University of the Immaculate Conception in Davao City.

The second batch of interns from Vietnam and Bangladesh are scheduled to arrive on 28 September 2008.



## Chinese Translation Project

A second project of the GIQAC project includes the translation and publication of existing and new training resources into Chinese which will assist enormously in capacity building in a country characterised by having a large number of QA agencies at the regional level, and be of much use throughout the region, wherever Chinese is spoken or where Chinese professionals live and work.

The project involves the Chinese translation and publishing of the publication 'Cross-border Tertiary Education: a Way towards Capacity Development' and a series of workshops held in the framework of the translation project.
