From 30 November until 2 December 2011, INQAAHE and ENQA organise a joint conference "Internationalisation and QA: Connecting European and Global Experiences". The conference takes place in Brussels, Belgium at the [Metropole Hotel](#).



The first day (30 November 2011) is organised by INQAAHE and is entitled "Quality of International Education in the Professions". During this day INQAAHE will pay a tribute to Dr Marjorie Peace Lenn, one of the founders of INQAAHE in 1991, who sadly died last year. Marjorie's main interests, the various forms of international higher education and its relation with the professional accreditors will be explored through presentations and workshops.

The second day (1 December 2011) 'Connecting European and Global experiences' is jointly organised by ENQA and INQAAHE. Attention will be paid to (recently) established European and International disciplinary accreditation initiatives and their relation to (national) QA systems. Also during this day mutual recognition in Europe, Latin-America and the Asia-Pacific region will be addressed.

The third day (2 December 2011) 'European Quality Labels and Quality Assurance' is organised by ENQA. During this day the nature of so-called quality labels in terms of their aims and objectives will be analyzed.

News from Other Networks



20 More experts added to the Database of Consultants

Twenty more experts from the Arab region have been added to the Database of Consultants since Sep. 1, 2011, which is the result of cooperation between the Arab Network for Quality Assurance Agencies in Higher Education (ANQAHE) and the Asia Pacific Quality Network (APQN). Currently the database includes 78 experts. The Database is available at: <http://www.apqn.org/services/consultantsdb/>

In addition on 1 September 2011, APQN and International Network of Quality Assurance Agencies in Higher Education (INQAAHE) jointly launched the next round of expansion of the Database. The heads of quality assurance agencies of the two networks have been requested to nominate experts for the Database by Sep. 30, 2011. Those who have already been included in the database have been asked to update their details.

APQN-INQAAHE Workshop on Good Practices in Quality Assurance 25 October 2011, Tokyo



In order to strengthen the capacity of quality assurance agencies to develop and assess good practices in quality assurance, APQN and INQAAHE are jointly organizing a workshop. The workshop aims at giving APQN members an opportunity to share their good practices in quality assurance. The workshop is sponsored from GIQAC funds and there is no registration fee. The workshop will be held in Tokyo on 25 October 2011. NIAD-UE, an APQN member, will host the event. The event is for APQN members only.

The focus of the workshop is for the participants to share and discuss their organisations' good practices, i.e., practices that are already being applied by the member agencies as part of their external quality assurance responsibilities. All types of practices are permissible as long as they relate to the participating agencies quality assurance activities. It is a requirement for participation that each member agency submits at least two good practices in writing prior to the workshop and agrees to submit these for review for inclusion in the INQAAHE database for Good Practices in Quality Assurance (GPQA). If the practice is approved by INQAAHE, it will be uploaded onto the INQAAHE GPQA and be a resource for the international quality assurance community.

Central Asian Network on Quality Assurance and Accreditation (CANQA) established



The Central Asian Network on Quality Assurance and Accreditation (CANQA) has been created within the Tempus project. The project has been initiated and organised by the Vrije Universiteit Brussel (Belgium) and the Education Network Association (Central Asia www.ednet.edu.kg). The long-term goal of the project is the development and implementation of quality assurance and quality culture in the higher education of Central Asia. The project involves 32 members from Belgium, Poland, Spain, Holland, Kyrgyzstan, Kazakhstan, and Tajikistan.

On 30 November 2010 during the members' seminar of the project consortium CANQA was established in Almaty, Kazakhstan, by the support of 17 Higher Education Institutions, 3 partner organizations and 3 ministries of education. Members of CANQA are the Education Network of educational establishments EdNet (the Kyrgyz Republic), the Center for progressive technologies in education (the Republic of Tajikistan), and the Kazakh National University.

One of the main goals of the CANQA project is to develop internal and external quality assurance systems in Central Asia, together with the development of accreditation agencies in partner countries, particularly in Kyrgyzstan, Kazakhstan and Tajikistan. Recently two agencies for quality assurance and accreditation were established in Kyrgyzstan and Tajikistan.

From 29 to 31 August 2011 CANQA organised an international seminar in Kyrgyzstan on internal and external quality assurance systems and accreditation of higher educational institutions. Questions on how to prepare a self-assessment report, the conduction of accreditation procedures in the university and about the experiences in attracting students to participate in accreditation procedures were discussed in the seminar.

During the seminar, participants were able to meet with Dr. Achim Hopbach (President of the ENQA), who presented them the latest trends in higher education in Europe. Achim also shared his experience of quality assurance in the European Higher Education Area and the various ENQA activities in which he has been involved.

2011 AQAN Seminar and Roundtable Meeting



The 2011 AQAN Roundtable Meeting will be hosted by the Brunei Darussalam National Accreditation Council (BDNAC) in Bandar Seri Begawan, Brunei from 4 until 6 October 2011.

The theme for the annual gathering for 2011 is *'Building Regional Confidence towards Harmonizing ASEAN Higher Education'*.

The program will start with one day seminar and followed by the 4th Roundtable Meeting in which, among others, the proposed AQAN constitutions will be tabled to the member countries for its adoption.

Results of Japan University Accreditation Association



The Japan University Accreditation Association (JUAA) currently performs Certified Evaluation and Accreditation in 5 fields (universities, junior colleges, law schools, professional graduate business schools and professional graduate schools of public policy). JUAA has finalized the results of accreditations for 2010.

On accepting applications for University Accreditation from 63 universities, the JUAA has undertaken the evaluative process. The evaluation including document-analysis and site-visit have been conducted by the University Accreditation Committee with more than 170 subcommittees/panels and approximately 680 evaluators.

As a result of the evaluation, the JUAA has finally decided to award accreditation to 56 universities satisfying the JUAA *University Standards*. The names of those accredited universities can be found at:

Graduate Certificate in Quality Assurance 2012



The LH Martin Institute for Higher Education Leadership and Management, at the University of Melbourne send greetings to readers of INQAAHE News.

The GCQA offers a comprehensive academic program for the training and professional development of quality assurance professionals. This one-year, part-time online graduate program has been developed in close consultation with the International Network of Quality Assurance Agencies in Higher Education (INQAAHE) and is awarded by the University of Melbourne for professional recognition internationally.

Being a fully online program, it offers maximum flexibility. Participants follow two compulsory modules after which they choose one of two electives. Program staff are international experts in quality assurance and higher education policy and management.

The program features a fully online program, developed according to current state-of-the-art online teaching methodologies, supported by extensive program resources. It offers integrated learning via theory, case studies, moderated discussion boards, virtual teamwork, webinars and work-based assignments.

2012 will be the third year the GCQA is offered, with the program being continuously upgraded based on participant feedback. Our GCQA students have hailed from 23 countries, across all continents. Interested and successful students may carry credit from the GCQA into a masters program.

INQAAHE will support the GCQA by providing six scholarships worth US\$5,000 each for GCQA candidates from the least developed countries. The deadline for application has been closed and selected participants will be informed in the coming weeks.
