President's Message

The new Board of INQAAHE was elected in April and is pleased to be able to report to Members the progress made since then, and some further projects under way.

2008 Members' Forum

This will be held in Buenos Aires on 14-16 May 2008. The theme is "The Evaluation of curricula in a context of change" and the program is in the conferences section of the INQAAHE website on the forthcoming events page or by clicking here...[Draft Programme](#)

As usual with the biennial Forum, the cost is minimised by not inviting and paying for keynote speakers. Instead, members planning to attend are invited to offer to lead one of the sessions listed in the program. Leading a session will require the leader to speak for about 20 minutes and to prepare a set of questions for the subsequent break-out discussion groups. Please consider whether you would be able to lead a session. Offers to lead a session should be sent to the Chair of the Program Committee, Dr Lis Lange [lange.l@che.ac.za], and copy to the Secretariat [inqaahe@hetac.ie]. Comments on program topics may also be sent to Dr Lange.

The Registration Fee will be \$260, payable on arrival in Buenos Aires. (This saves over 10% of the fee in transfer charges.)

The Chair of the Local Organising Committee is Dr Leandro Haberkfeld, who has joined the Board as an observer.

Constitution

The Board reviewed the Constitution and Members supported the proposed changes.

The most important change is the introduction of a category of Institutional Member to recognise the special relationship between education institutions and QA agencies in the education sector. It also recognises the centrality of the HE institution in the quality of education, and the increasing number of identifiable quality units and quality managers within institutions that are carrying out roles very akin to those of external QA agencies. In some areas, particularly in small states, there are institutions that provide a service akin to that of a quality agency.

All current higher education institution members of the Network will be identified and notified before their transfer to this new category.

Other changes include the introduction of a Vice-President position to take account of the heavy workload on Board members, and an increase in the number of co-opted positions to ensure that the Board can call on the expertise it needs in various areas.

In approving the changes to the Constitution, some Members mentioned other possible improvements. These will be considered in the 2008 review of the Constitution.

Guidelines for Good Practice (GGP)

This document, which was approved by the Members at the 2003 Conference, is based on work done in 1999, since when it has been incrementally amended. The Board decided it should have a thorough look at the Guidelines, and then let them stand for a five-year period so Members can use them without finding that the work is constantly superseded by new versions.

Members will note that the structure has been strengthened, and advice on how to use them has been included. Increasingly, QA agencies are themselves being reviewed, and often they opt to be checked against the GGP. In recognition of this, INQAAHE will list on the website, at the respective agency's request, agencies that have been found by an independent review to be acting in alignment with the GGP.

A hard copy version will be produced before the 2008 Forum.

INQAAHE Report

The INQAAHE 2007 Report will be sent to you within the next few days. This report, which was in draft form at the time of

the Toronto Conference, includes reports from the regions. INQAAHE will produce an annual report in the future, but for cost considerations we will only occasionally produce and mail a hard copy version. (Note that the version of the GGP in this report is the version that was current at the time of the Toronto Conference, and it has now been superseded by the version mentioned above.)

Global Initiative for QA Capacity-Building (GIQAC)

This initiative of the World Bank, in partnership with UNESCO, and with the support of INQAAHE, was reported to the Members at the Toronto Conference. Discussions on organisation have been taking place since then, UNESCO is drawing up draft procedures and the GIQAC Board will meet for the first time on 19 November, in Paris, with INQAAHE as a member.

As soon as possible, Members will be given further information, including how the fund will operate.

INQAAHE Website

The Board has recognised for some time that the INQAAHE website is not very functional. It was built single-handed in the early internet days and now needs a complete revision. The Secretariat is working with an internet host, and some initial ideas for re-design have been put forward.

2009 Conference

After extensive discussion and investigation, the Board confirmed Abu Dhabi in the United Arab Emirates as the venue for the 2009 Conference. The Conference will be early in March 2009.

The Board will now appoint a Program Committee to develop the content and structure of the Conference program. Anyone interested in being on the Committee should inform the Secretariat.
