- Advisory body under the President of the Russian Federation on the development of qualifications
- Coordinates the activities of participants in the IQA system
- The publication of the NPA on IQA issues is carried out after the approval of the NCPQ

ISSUES OF QUALITY OF EDUCATION IN THE RUSSIAN FEDERATION ARE DETERMINED BY

Federal law "On education in the Russian Federation" N 273-FZ, articles 95, 96 Decree of the President of the Russian Federation No. 249 of April 16, 2014 "On the National Council for professional qualifications under the President of the Russian Federation"

The state program "development of education", approved by Government decree No. 1642 of December 26, 2017. Appendix No. 1 to the state program of the Russian Federation "Development of education", p.46.

Government resolution No. 1052 of August 15, 2019

EMPOWERING THE PPA

By the decision of the National Council under the President of the Russian Federation on vocational qualifications, 20 may 2015, Association of financial market participants "Council for professional qualifications of the financial market" is defined as an organization performing the functions of the Council for Professional Qualifications Development (hereinafter – CPQD).





In accordance with the decree of the President of the Russian Federation of 16.04.2014 No. 249 "On the National Council for professional qualifications under the President of the Russian Federation" CPQD is empowered on issues related to the development of a system of professional qualifications in the Russian Federation, including organization of professional public accreditation of the basic professional educational programs of basic vocational training and (or) additional vocational programs.



ACHIEVEMENTS OF THE CPQD IN CONTEXT OF PROFESSIONAL PUBLIC ACCREDITATION OF EDUCATIONAL PROGRAMS



- 1200 experts on professional and public accreditation and independent qualification assessment were accredited
- experts provide various trajectories for evaluating the quality of education and educational programs throughout the Russian Federation, as well as provide consulting and methodological assistance in developing educational programs that meet the requirements of the labor market, including training standards for major state corporations



57 educational programs were professionally and publicly accredited



Mechanisms have been developed for mutual recognition of the results of professional-public and international accreditation, the results of state final certification and professional examination in the framework of independent assessment of qualifications



ROAD MAPS

The issues of independent assessment of the quality of education and PPA are reflected in:

- action plan ("road map") of the Bank of Russia to ensure the transition to a system of independent assessment of the qualifications of financial market specialists (signed by the Bank of Russia and the CPQD in 2019) (paragraphs 2.2.2. and 2.3).
- Rosfinmonitoring road map for the implementation of an independent assessment of qualifications in the field of CLPC/FT/FPWMD (countering the laundering (legalization) of proceeds from crime, the financing of terrorism, and the financing of the proliferation of weapons of mass destruction) (signed by Rosfinmonitoring and CPQD in 2019).

In accordance with paragraph 2.4 of the action plan ("road map") The Bank of Russia approved the concept and schedule for the transition to automated processes for independent assessment of qualifications of financial market specialists






CONDUCTING IQA IN A REMOTE FORMAT

Proctoring module

- The ability to conduct an independent assessment of qualifications in a completely remote online mode
- Identification of applicants and monitoring of the exam process by experts through access to web cameras and computer desktops
- Automatic system for tracking and notifying experts of violations
- Recording and storing video of the exam process
- System readiness for integration with EBS and ESIA



INTEGRATED ACCREDITATION PROCESS



process of integrated procedure for international and professionalpublic accreditation of educational programs





International accreditation is a procedure for assessing the compliance of Russian educational programs with international and European quality standards. it is carried out by accreditation agencies that are members of the European higher education quality assurance Association (ENQA) and registered in the European register of quality assurance agencies (EQAR)

Professional and public accreditation of professional educational programs is the recognition of the quality and level of training of graduates who meet the requirements of professional standards, labor market requirements for specialists, workers and employees of the relevant profile.



THE OBJECTIVE OF JOINT ACCREDITATION

External independent evaluation and confirmation of the quality of educational programs by professional associations and communities in Russia and abroad

Improving the quality of education and training of graduates, in accordance with the requirements of the labor market

Strengthening the competitiveness of educational programs at the national and international level



PARTICULAR PROBLEMS OF EVALUATING THE QUALITY OF EDUCATIONAL PROGRAMS

THE DIRECTION OF SOLVING PROBLEMS

- there are not enough students and graduates who have passed an independent assessment of the quality of training according to the assessment tools agreed with the CPQD
- lack of confirmed demand for the educational program, demand for graduates by employers, including targeted training
- lack of confirmation of employers 'participation:
 - in the design of educational programs, including the development of planned results of its development, evaluation materials, curricula, work programs, practice programs, topics of final qualifying works that are significant for the relevant areas of professional activity;
 - in the organization of project work of students;
 - in the development and implementation of practical training programs, the formation of planned results of their passage;
 - in the development of topics for term papers and final qualification papers that are relevant to the relevant areas of professional activity.

COOPERATION WITH AKKORK

In October 2019, the Council for Professional Qualifications Development approved a Method for combining the requirements of professional and public accreditation and international accreditation of the Agency for quality control of education and career development *.

- Increase in domestic and international student mobility.
- Attracting the best Russian and international teachers.
