# Barriers to Quality Education

...

# 1. Economic Barrier

Impacts the physical facilities to provide a safe and clean learning environment, the availability of teaching aids and resources to facilitate learning, the localization of textbooks, and the offering of skills training and continuing education for teachers.

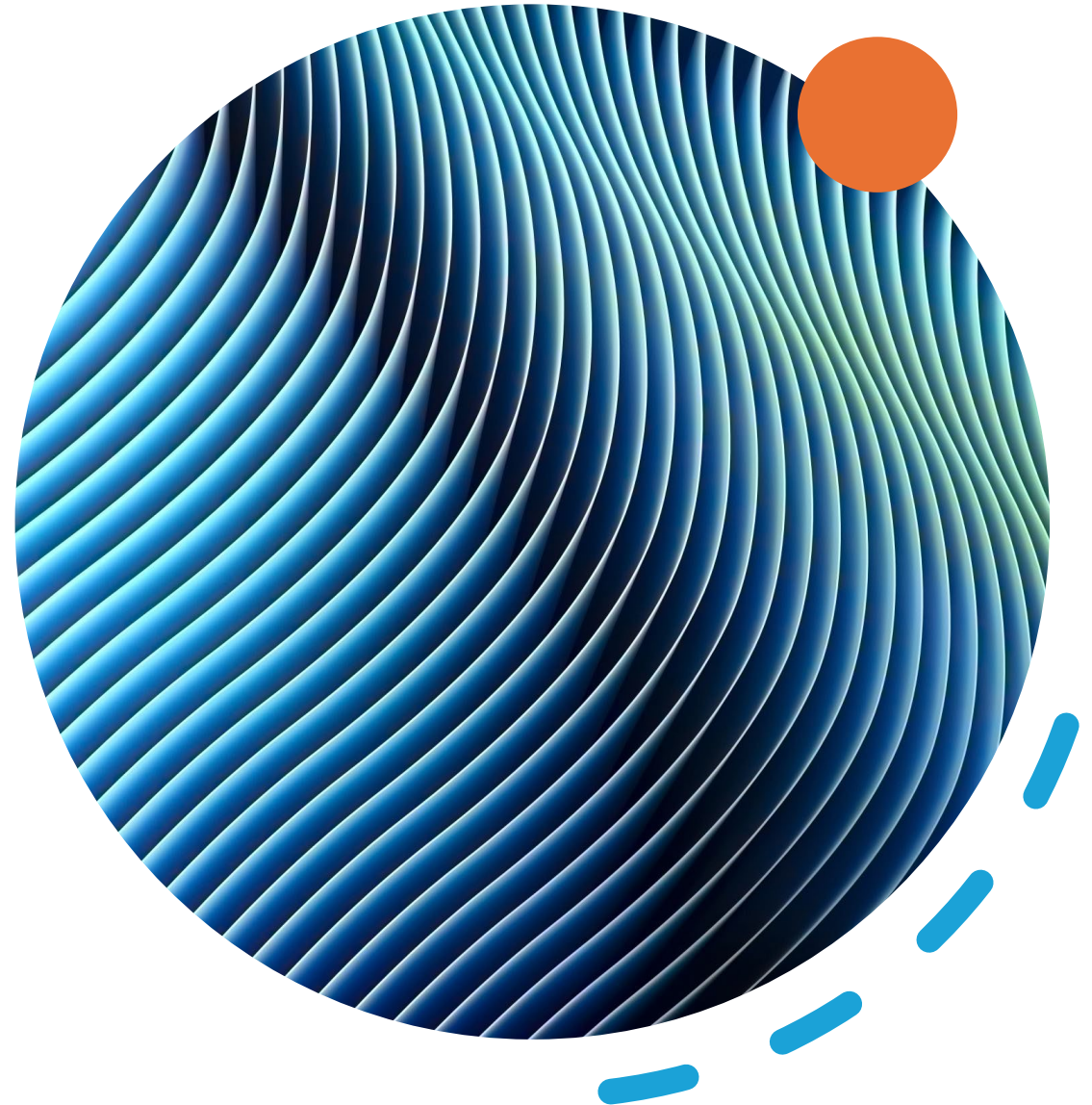


Low salaries and high School fees effectively reduce education access for the poor.

## 2. Access Barrier

There are a number of different barriers to access to a quality education, including :

- Physical barriers,
- Financial barriers,
- Time,
- Sociocultural barriers,
- Motivational barriers,
- Educational quality shortcomings,
- Inadequate supply of educational spaces and teachers, and the potential for educational discrimination





### 3. Curriculum Barrier

The quality of a curriculum is the medium by which educational and social goals are achieved, and that curriculum and instruction are the primary tools by which skills, knowledge, and behaviors relevant to quality education are created.

The relevance and quality of the curriculum, as well as attaining high academic standards, are critical to a quality education system.



## 4. Teacher Quality and Availability Barrier

- Teachers need specialized training in education.
- Many countries are struggling to find enough high-quality people of both genders to enter the teaching profession
- Shortage of good teachers...
- The quality of an education system cannot exceed the quality of its teachers;

# 5. Infrastructural Barriers



- Physical spaces and tools necessary for learning, such as well-constructed school buildings, furniture, and essential materials for education.
- Information-related infrastructure, such as libraries and laboratories as well as connectedness to today's global world.
- Infrastructure services such as access to water and sanitation, school buildings, the availability of electricity, and proximity to schools, among others,
- Crowded classrooms negates quality



## 6. Policy Barriers

- Lack of Policy to support Quality Education

- Inadequate checks and control, relatively lax supervision, and review of work,
- Teachers and administrators, the people primarily responsible for the implementation and execution of educational policies

## 7. Poor Educational Leadership Barriers



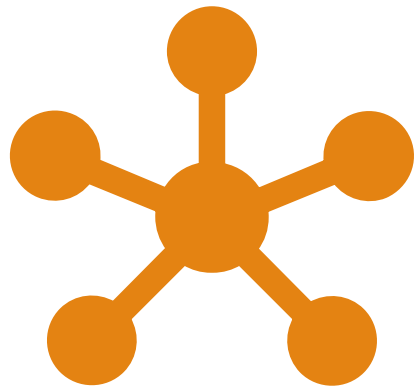
- The quality of the leader has been identified as a significant factor in the maintenance and improvement of instructional learning and environment.

- Improve the quality of pre-primary, primary, and lower secondary education, and grade repetition, by regularly assessing children, diagnosing learning levels accurately and in a timely manner, tailoring instruction, and providing remediation and learning support.
- Design support programs to address multiple deprivation. - Increase the effectiveness, fairness, gender sensitivity, and relevance of educational legislation, policies, and financing, and enhance budget transparency and accountability.
- Raise awareness about best practices for enhancing learning achievement and outcomes and for enhancing oversight and accountability in education.
